BE IT KNOWN that on this the 18<sup>th</sup> day of April, 1988, the Honorable Commissioners' Court of Johnson County met in the Courthouse in the City of Cleburne in a special called session with all members present, and after the invocation and pledge of allegiance, the following were considered:

6. MARKET SQUARE

Motion was made by Comm. Miller, seconded by Comm. York, to accept the low bid of Cole Portable Toilets to provide a porta-john at the Market Square at a charge of \$60.00 per month, to be in use from now until October 1, 1988.

All voted aye; motion passed.

10. CITIZENS COMMITTEE TO STUDY OLD HOSPITAL BUILDING

No action taken.

5. REQUEST OF TAX COLLECTOR AND 2 DEPUTIES TO ATTEND SEMINAR

Motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the Tax Collector and three deputies attending the Annual Conference and Workshop to be held in Wichita Falls on May 15-17, 1988.

All voted aye; motion passed.

4. REQUEST OF VETERANS SERVICE OFFICER TO ATTEND SEMINAR

Motion was made by Comm. York, seconded by Comm. Harmon, to approve the Veterans Service Officer attending the Spring conference in Dallas on April 21-22, 1988.

All voted aye; motion passed.

1. AWARD BID ON HOSPITALIZATION INSURANCE

Bids will be studied, and this item will be re-scheduled for a later meeting. No action taken.

16. ADVERTISING FOR BIDS

Motion was made by Comm. York, seconded by Comm. Harmon, to authorize the advertising for bids for heating and air conditioning repairs for county buildings and for automobile repairs for the Sheriff's Office vehicles.

All voted aye, motion passed.

14. AWARD BIDS ON EMULSIFIED ASPHALTS & ASPHALTS

Motion was made by Comm. Harmon, seconded by Comm. York, to approve the low bid of Riffe Petroleum, doing business as Elf Asphalt, on CRS-2, CRS-2h, MS-2, and HFRS-2, of 59.72 cents per gallon, and to approve the bid of Southern Asphalt and Petroleum for RC-250 at 62.45 cents per gallon, AC-5 at 48.70 cents per gallon, and MC-30 at 61.30 cents per gallon.

All voted aye; motion passed.

7. TAX COLLECTION CONTRACT WITH CITY OF ALVARADO

Motion was made by Comm. York, seconded by Comm. Miller, to approve a Tax Collection contract between Johnson County and the City of Alvarado for a period of one year, beginning on July 1, 1988, subject to approval by the Alvarado City Council.

All voted aye; motion passed.

2. CHEVRON PIPELINE COMPANY

Motion was made by Comm. Miller, seconded by Comm. Harmon, to approve Chevron Pipeline Company obtaining a one-acre site and a .78 acre access easement at the old Park on the west side of the overpass on Highway 174 North in Cleburne in a friendly condemnation suit at a cost of \$18,000.00, with the private road easement designating that Chevron Pipeline Company and Johnson County or anyone to whom Johnson County would sell the remainder of the property would have equal access to the private road easement, and that further, the Commissioners' Court approves the preliminary plat of the Cleburne Station and authorizes Chevron Pipeline Company to present the preliminary plat to the City of Cleburne Planning and Zoning Commission.

All voted aye; motion passed.

Motion was made by Comm. York, seconded by Comm. Miller, to approve three of the old copy machines being used at the offices of Precinct No. 2, Precinct No. 3, and the Court Coordinator for the District Judges.
