## 1. JOHNSON COUNTY LAW ENFORCEMENT CENTER

A progress report was given by Frank Neal, Engineer, and Danny Butler, Construction Manager with no action being taken.

### APPROVAL OF BILLS

Motion was made by Comm. Roe, seconded by Comm. Harmon, to approve the bills as presented by the County Auditor, in addition to a bill for Frank Neal in the amount of \$10,642.44 for engineering work on the Law Enforcement Center.

All voted aye; motion passed.

## APPROVAL OF MINUTES

Motion was made by Comm. Roe, seconded by Comm. York, to approve the minutes of the meetings of May 9 and May 16, 1988, as written.

All voted aye; motion passed.

# SUBDIVISIONS

#### 1. NOLAN RIVER ESTATES, PHASE IV

Motion was made by Comm. Roe, seconded by Comm. Harmon, to approve the final plat of Nolan River Estates, Phase IV subdivision subject to the \$1,500.00 inspection fee being paid, and a \$137,000.00 Letter of Credit being filed with the County Auditor's office to insure the construction of the roads in accordance with the County's standards, and the markings of the 100-year flood boundary on the final plat with permanent marking.

All voted aye; motion passed.

## 2. HOMESTEADS

Motion was made by Comm. York, seconded by Comm. Harmon, to approve the County assuming maintenance of the roads in the Homesteads subdivision of Sallys Way street from County Road 611 to County Road 616, Celia Court, and all of the Phase VIII, which have a total mileage of 3.19 miles and have been maintained by the developer for at least two years since the roads were completed.

## 3. LARK MEADOWS

Motion was made by Comm. York, seconded by Comm. Miller, to approve the County assuming maintenance of the roads in Lark Meadows, Phase I and Phase II, which roads have been maintained by the developer for at least two years since the roads were completed.

# 1. Air Conditioning and Heating Repairs for County Buildings

Motion was made by Comm. York, seconded by Comm. Roe, to approve the Commissioner in Precinct No. 2 making road repairs on that portion of County Road 920 within the city limits of Burleson, with the City of Burleson paying the cost of labor and materials that are used on this road.

All voted aye; motion passed.

## 2. APPOINTMENT OF BOARD MEMBER TO RURAL FIRE COMMISSION

Motion was made by Comm. Roe, seconded by Comm. Harmon, to appoint Carlisle McFall of the Godley-Bono area as a Board Member of the Johnson County Rural Fire Commission to replace Arval Martin, Jr.
