COUNTY OF JOHNSON

BE IT KNOWN that on this the 23rd day of January, 1989, the Honorable Commissioners' Court of Johnson County, Texas, met in regular session with all members present, in the Courthouse in the City of Cleburne, Johnson County, Texas, and following the invocation and the pledge of allegiance, the following items were considered:

JOHNSON COUNTY LAW ENFORCEMENT CENTER

A progress report was given by Frank Neal, Engineer, and Danny Butler, Construction Manager.

Motion by Comm. Harmon, seconded by Comm. Estes, to approve advertising for bids for a recording system for telephones and radios, a fuel tank with a 10,000 gallon capacity, a fuel pump, and for a fence around the impound yard at the new Law Enforcement Center.

All voted aye; motion passed.

COMMISSARY SERVICE AT COUNTY JAIL

Lonnie Gallop, vendor providing commissary items at the County Jail, agreed to submit a revised price list, with the County providing hygiene items for indigent prisoners.

No action was taken at this time.

REQUEST FOR CITY OF ALVARADO FOR STREET REPAIRS

Motion was made by Comm. Miller, seconded by Comm. Harmon, to approve the Commissioner in Precinct 3 repairing streets in the City of Alvarado with the City of Alvarado paying the actual costs of labor and materials. The County Attorney's office is to prepare a written contract and billing is to be sent through the County Auditor's office.

All voted aye; motion passed.

APPROVAL OF BILLS

Hewlett, to approve Prec. 2 purchasing a rebuilt motor for a chip spreader, for repair of a transmission, for the purchase of an extension bar for an asphalt distributor; and to approve Prec. 3 purchasing two mobile radios and one base station; and for Prec. 1 & 2 purchasing a telephone system with four telephones and up to 3 lines each; all of these items costing more than \$1,000.00 and less than \$5,000.00.
