BE IT KNOWN that on this the 1st day of May, 1989 the Honorable Commissioners' Court of Johnson County, Texas met in special session with all members present, in the Courthouse in the City of Cleburne, Johnson County, Texas, and following the invocation and the pledge of allegiance, the following items were considered:

APPROVAL OF MINUTES

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve the minutes of the Commissioners' Court meeting on April 24, 1989, with the corrections as noted.

All voted aye; motion passed.

CONSENT AGENDA

A motion was made by Comm. Hewlett, seconded by Comm. Harmon, to approve the items on the Consent Agenda as follows: Approval of corrected minutes of April 10 and 17, 1989 meetings; Request of 18th District Court Reporter to attend a Seminar; and Request of Purchasing Officer to attend a Seminar.

All voted aye; motion passed.

INVESTMENT OF COUNTY FUNDS

A discussion was held concerning investment of County Funds, with no action being taken.

ADVERTISING FOR BIDS

A motion was made by Comm. Miller, seconded by Comm. Estes, to approve the Commissioner in Precinct 1 advertising for the purchase of a used motor grader with four old graders as trade-in or to be sold separately, advertising for the purchase of tax statements, oil changes for Sheriff's Office vehicles for a period of one year, and automobile liability and property insurance including general liability insurance.

PERSONNEL POLICY

A motion was made by Comm. Harmon, seconded by Comm. Estes, to clarify the personnel policies of Johnson County to state that the County will pay hospitalization insurance for an employee as long as the employee receives a salary check from Johnson County, and if an employee is not receiving a salary check from the County, then that employee would have to reimburse the County for the cost of his/her hospitalization insurance each month if they wish to continue that coverage in effect. The employee also has the option of continuing to pay for their dependents coverage on the hospitalization insurance during the time that the employee was not receiving a check form the County.

All voted aye; motion passed.

AREA 5 HEALTH DEPARTMENT

No action was taken.

ADVERTISING FOR BIDS

A motion was made by Comm. Hewlett, seconded by Comm. Miller, to authorize advertising for bids to move the minimum security building from the site of the old jail.

All voted aye; motion passed.

On Thursday, May 4, 1989, the Commissioners' Court reconvened at 9:30 A.M. The Commissioners' Court discussed the contract provisions for the District of Columbia and the Johnson County Law Enforcement Center with Sheriff Eddy Boggs, Dr. Arthur Raines, and Dale Hanna, County Attorney.
