FARM TO MARKET ROAD PROJECTS

The Court met with Mr. J. R. Stone and Mr. Elvis Shockley of the Texas Department of Highways and Public Transportation to discuss future Farm to Market Road projects in Johnson County.

TAX COLLECTION CONTRACT FOR ALVARADO I.S.D.

A motion was made by Comm. Estes, seconded by Comm. Miller, to approve the Johnson County Tax Assessor-Collector collecting taxes for the Alvarado I.S.D. for July 1, 1989, through June 30, 1990, at a cost of 70¢ per account for current tax collections.

All voted aye; motion passed.

ADVERTISING FOR BIDS

A motion was made by Comm. Hewlett, seconded by Comm. Miller, to approve advertising for bids for vehicle repair for the Sheriff's Office vehicles, air conditioning and heating repairs and work on County buildings, and for Precinct #2 advertising for the sale of a wrecked aluminum trailer and a used motor grader.

PURCHASES FROM \$1,000.00 TO \$5,000.00

ACQUIRING RIGHT OF WAY ON C.R. 1217

A motion was made by Comm. Harmon, seconded by Comm. Miller, to approve the Commissioner in Precinct 1 purchasing approximately .5 to .75 of an acre of right of way on County Road 1217 from F. J. Hogan at a price of \$1,500.00, which will be acquired to eliminate the need for a culvert.

A motion was made by Comm. Estes, seconded by Comm. Harmon, to approve the items on the Consent Agenda, a Sheriff's Deputy to attend a Seminar and Line Item Budget Amendments as presented by the County Auditor.

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve the minutes of the Commissioners' Court meetings on May 1, May 8, and May 15, 1989, as written.

A motion was made by Comm. Hewlett, seconded by Comm. Miller, to approve placing an additional portable toilet at the Market Square at a cost of \$50.00 per month.

JOHNSON COUNTY LAW ENFORCEMENT CENTER

A motion was made by Comm. Hewlett, seconded by Comm. Miller, to approve the hiring of one additional cook at an annual salary of \$12,000.00 and one additional secretary at an annual salary of \$11,217.00, as of June 1, 1989.

Representatives from IBM and Northeast Texas Data met with Commissioners' Court and Larry Jenkins in regard to problems which have been encountered with the computer system.
