#### JOB CLASSIFICATION PLAN

A motion was made by Comm. Harmon, seconded by Comm. Hewlett, to approve Johnson County adopting Pay Plan Policies, Personnel Change Notice, Performance Appraisal and the recommended changes in the Job Classification of County employees for the Job Classification Plan.
