#### SUBDIVISIONS

#### ROUGH ROAD ADDITION (ASSUME ROADS BY CONTRACT) - PRECT. 2

A motion was made by Comm. Harmon, seconded by Comm. Estes, to approve the Road and Street Dedication and Maintenance Agreement and Hold Harmless Agreement and Release for the Rough Road Addition Subdivision in which the lot owners have paid \$8,738.73 to the County Treasurer's Office for the actual cost of materials and cost of hauling the materials to be used by the Precinct Commissioner in upgrading the roads to all-weather roads. This is a subdivision that was more that 80% sold out on September 1, 1983.
