BE IT KNOWN that on the 11<sup>th</sup> day of May, 1992, the Honorable Commissioners' Court of Johnson County, Texas, met in regular session with all members present, in the Courthouse in the City of Cleburne, Johnson County, Texas, and following the invocation and the pledge of allegiance the following items were considered:

APPROVAL OF BILLS

A motion made by Comm. Estes, seconded by Comm. Harmon, to approve paying the monthly bills as presented by the County Auditor.

All voted aye; motion passed.

PURCHASES FROM \$2,500.00 to \$10,000.00

No action was taken.

ADVERTISING FOR BIDS

A motion was made by Comm. Hewlett, seconded by Comm. Brown, to approve advertising for bids for: flat tire repair, vehicle and equipment parts, and vehicle repairs for the Sheriff's Department; and removal of an underground storage tank and advertise for an above the ground storage for Precinct #4.

AWARD BID NEW PICKUP - PRECINCT #4

A motion was made by County Judge Joe Durham, seconded by Comm. Brown, to accept the low bid of Cleburne Motor Co, for \$10,540.92 per unit for two (2) units, for new pickups for Precinct #4.
