PURCHASES FROM \$2,500.00 to \$10,000.00

A motion was made by Comm. Harmon, seconded by Comm. Brown, to approve the following purchases: Precinct #4 fencing and the County Extension Office to purchase three (3) PC's at a cost of \$5,400.00.

ADVERTISING FOR BIDS
