BE IT KNOWN that on the 10<sup>th</sup> day of June, 1996 the Honorable Commissioner's Court of Johnson county met in regular session with all members present in the Courthouse in the City of Cleburne, Johnson County, Texas, and following the invocation and the Pledge of Allegiance, the following items were considered:

V. PRECEDING BUSINESS

1. APPROVAL OF MINUTES

A motion was made by Comm. Harmon, seconded by Comm. Estes to approve the minutes for the meeting of May 28, 1996.

All voted aye; motion passed.

2. FIRE WORKS IN COUNTY

A motion was made by Comm. McFall, seconded by Comm Estes to not impose a ban on fire works at this time.

All voted aye; motion passed.

3. MOHR ESTATES, PHASE II (PLAT REVISION) - LOTS 12 & 13 – PCT. #3 a

A motion was made by Comm. Estes, seconded by Comm. Harmon to approve the Mohr Estates, Phase II (Plat Revision) Lots 12 & 13 - Pct. #3.

All voted aye; motion passed.

4. TEMPORARY PERMIT FOR SEPTIC SYSTEM – LAKEVIEW ESTATES

A motion was made by Comm. Estes, seconded by Comm. Thompson to approve a temporary 120-day permit for a septic system for Lakeview Estates.

All voted aye; motion passed.

5. AWARD BIDS/PROPOSALS/QUOTES

a. #96-40 NEW 5/8 TON PIC UP FOR PCT. #1

A motion was made by Comm. McFall, seconded by Comm. Estes to approve the bid given by Cleburne Motor Company on a Ford F-150 for \$14,555.00 for Pct. #1.

b. #96-38 BRIDGE CONSTRUCTION CR 528 - PCT. #3

A motion was made by Comm. Estes, seconded by Comm. Thompson to approve the low bid given by Harris Welding & Construction for \$28,500.00 with a start date of September 15, 1996

Cole Lancaster was present to give an update on the computer equipment.

4. INMATE PHONE SERVICE CONTRACT – SOUTHWESTERN BELL TELEPHONE

A motion was made by Comm. Thompson, seconded by Comm. Harmon to approve inmate Phone Service Contract with Southwestern Bell Telephone.

All voted aye; motion passed.

1. PURCHASES FROM \$2,500.00 TO \$15,000.00

A motion was made by Comm. Estes, seconded by Comm. Thompson to approve the repair of a Maintainer for Pct. #3 that may cost more than \$2,500.00.

All voted aye; motion passed.

2. ADVERTISING FOR BIDS/PROPOSALS

A motion was made by Comm. Harmon, seconded by Comm. Estes to go out for bids on Plumbing Repair, Air Conditioning and Heating Repair, Tire Repair, Heavy Equipment Repair, Automatic Transmission Repair, and Replacement of a Bridge on County Road 204 for Pct. #4.

All voted aye; motion passed.

3. TRAFFIC SIGNS

4. APPOINTMENT TO THE REGIONAL TRANSPORTATION COUNCIL

A motion was made by Comm. Estes, seconded by Comm. Thompson to appoint Commissioner Ron Harmon to the Regional Transportation Council.

6. INTERLOCAL AGREEMENT WITH THE CITY OF KEENE, PCT. #4

A motion was made by Comm. Thompson, seconded by Comm. Estes to approve the Inter-local Agreement with the City of Keene and Pct. #4.

7. PURCHASE OF R.O.W. FOR BRIDGE ON COUNTY ROAD 616 - PCT. #3

Comm. Estes requested that this item be re-set for the next meeting.

VIII. CONSENT AGENDA

A motion was made Comm. Estes, seconded by Comm. McFall to approve the items on the Consent Agenda.

All voted aye; motion passed.

IX. WORKSHOP
