5. ACTION ON REQUEST FROM NOLAN RIVER KENNEL CLUB FOR USE OF MARKET SQUARE FOR RABIES CLINIC, MARCH 6, 1999

A motion was made by Comm. McFall, seconded by Comm. Thompson, to approve the Nolan River Kennel Club using the Market Square for a free rabies clinic on March 6, 1999.

1. PURCHASES FROM \$2,500.00 TO \$15,000.00

A motion was made by Comm. McFall, seconded by Comm. Harmon, to approve placement of a newspaper rack by the Fort Worth Weekly on county property.

6. ACTION ON INTERLOCAL AGREEMENT REGARDING THE REGULATION OF SUBDIVISIONS AND FUNDING WITH THE NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS
