COMMISSIONER'S COURT

BE IT KNOWN that on the 22nd day of May, 2000, the Honorable Commissioner's Court of Johnson County, Texas, met in regular session at 9:00 A.M., with all members present in the Courthouse, in the City of Cleburne, Johnson County, Texas, and following the Invocation led by Comm. Thompson, and the Pledge of Allegiance, the following items were considered:

I. ANNOUNCEMENTS

County Judge Roger Harmon announced the opening of daily AMTRACK service to Johnson County.

VI. PRECEDING BUSINESS

1. APPROVAL OF BILLS

A motion was made by Comm. McFall, seconded by Comm. Thompson, to approve the bills as presented by the County Auditor.

All voted aye; motion passed.

2. ACKNOWLEDGMENT OF RECEIPT OF THE COUNTY AUDITORS REPORT TO THE COMMISSIONER'S COURT

Judge Harmon acknowledged receipt of the County Auditor's Report to the Commissioner's Court.

3. ACTION ON PRELIMINARY PLAT

a. OUTER LIMITS EXPRESS ADDITION: LOTS 1-8, BLOCK L – PRECINCT #3

A motion was made by Comm. Carpenter, seconded by Comm. Thompson, to approve the preliminary plat of Outer Limits Express Addition: lots 1-8, block L in Precinct #3.

All voted aye; motion passed.

b. KEY WEST SUBDIVISION – PRECINCT #4

A motion was made by Comm. Thompson, seconded by Comm. McFall, to approve the preliminary plat of Key West Subdivision in Precinct #4.

All voted aye; motion passed.

4. ACTION ON FINAL PLAT

a. QUAIL RUN ESTATES, PHASE I: LOTS 1-9, BLK 1; LOTS 1-14, BLK 2; LOTS 1-19, BLK 3; LOT 1, BLK 4; LOTS 1-13, BLK 5; AND LOTS 1-3, BLK 6 – PRECINCT #4

A motion was made by Comm. Thompson, seconded by Comm. Carpenter, to approve the final plat of Quail Run Estates, Phase I: lots 1-9, blk. 1; lots 1-14, blk. 2; lots 1-19, blk. 3; lot 1, blk. 4; lots 1-13, blk. 5; and lots 1-3, blk. 6 in Precinct #4.

a. BID #2000-27: INVENTORY AND AUDIT OF JOHNSON COUNTY TELEPHONE BILLINGS

A motion was made by Comm. Harmon, seconded by Comm. McFall, to approve the bid from Phone Billing Examiners (PBX) to audit Johnson County's telephone billings for a fee of 60% of the refunds recovered by PBX and giving Judge Harmon the authority to sign the contract.

b. BID #2000-28: PURCHASE OF NEW 2000 6/8 YARD DUMP TRUCK – PRECINCT #1

A motion was made by Comm. McFall, seconded by Comm. Harmon, to approve the bid from Durant Chevrolet for a new 2000 model 6/8 yard dump truck for Precinct #1 in the amount of \$39,000.00.

2. ADVERTISING FOR BIDS/PROPOSALS

A motion was made by Comm. Carpenter, seconded by Comm. Thompson, to approve advertising for bids/proposals for the sale of two (2) used Mack trucks and one (1) used end dump trailer, Precinct #4, and one (1) grade-all,

Precinct #3, at Ritchie Brothers Auction; for replacement or repair of a bridge on CR 401 in Precinct #3 and for replacement or repair of a bridge on CR 401 in Precinct #4.

All voted aye; motion passed.

3. ACTION TO ACCEPT RESIGNATION OF DONNIE WILLIAMS AS INDIGENT HEALTH CARE APPEAL HEARINGS OFFICER

Passed for discussion in workshop session.

4. ACTION TO AMEND BUDGET PURSUANT TO SECTION 111.010(c) OF THE LOCAL GOVERNMENT CODE FOR THE ISS DEPARTMENT AND TO CLAIM EXEMPTION FROM COMPETATIVE BIDDING UNDER SECTION 262.024(d) AS A SOLE SOURCE PROVIDER

A motion was made by Comm. Harmon, seconded by Comm. Thompson, to approve amending the budget pursuant to Section 111.010(c) of the Local Government Code for the ISS Department line item #010-409-570 in the amount of \$224,647.00 for an upgrade to the AS400 and to claim exemption from competitive bidding under Section 262.024(d) as a sole source provider.

5. ACTION ON REQUEST TO APPLY FOR DYED DIESEL FUEL BONDED USER PERMIT FOR PURCHASING TAX-FREE DIESEL FUEL FOR OTHER THAN AGRICULTURAL PURPOSE

A motion was made by Comm. McFall, seconded by Comm. Carpenter, to approve applying for a Dyed Diesel Fuel Bonded User Permit for purchasing tax/free diesel fuel for other than agricultural purposes.

by the comptroller from electric cooperatives under Section 74.602 of the Texas Property Code.
