COMMISSIONER'S COURT

BE IT KNOWN that on the 25th day of October, 2010, the Honorable Commissioner's Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M., with all members present, and following the Invocation led by Dean Elliott, Associate Pastor of the Cleburne Bible Church and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on October 21, 2010 at 1:09 P.M., were considered:

VI. PUBLIC HEARING

The Commissioner's Court opened a Public Hearing at 9:05 A.M. to discuss:

1. "IN ACCORDANCE WITH CHAPTER 343 OF THE TEXAS HEALTH & SAFETY CODE, THE PREMISES LOCATED AT 104 ROBIN DR.,
BURLESON, TEXAS 76028, HAS BEEN IDENTIFIED AS A PUBLIC NUISANCE AND TODD D. HENDERSON HAS BEEN IDENTIFIED AS THE PERSON RESPONSIBLE FOR CAUSING OR MAINTAINING A PUBLIC NUISANCE ON THE PREMISES."

Detective Steve Shaw spoke in reference to Chapter 343 of the Texas Health & Safety Code, the premises located at **104 Robin Dr., Burleson, Texas 76028** having been identified as a public nuisance and **Todd D. Henderson** has been identified as the person responsible for causing or maintaining a public nuisance on the premises. Detective Shaw stated that the property is located in a platted subdivision and needs to be mowed due to overgrown grass and weeds. He stated the process began on May 17, 2010 by identifying the owner of the property, Todd D. Henderson and at that time back taxes were owed in the amount of \$5,592.00. A Notice of Violation letter was sent to Todd D. Henderson without a response from Mr. Henderson. The case was filed with the Justice of the Peace Court, Precinct #2. Mr. Henderson did not show for the court date and at that time Detective Shaw requested the case be dismissed and be re-filed with the Commissioner's Court. A Notice of Nuisance letter was sent to Mr. Henderson by certified mail and confirmation of Mr. Henderson's receipt of that letter was received. Detective Shaw said he went back out to the property on October 19, 2010 and no abatement work had been done and the back taxes now owed is \$8,690.00. The hearing was closed at 9:07 A.M.
