"IN ACCORDANCE WITH CHAPTER 343 OF THE TEXAS HEALTH & SAFETY CODE, THE PREMISES LOCATED AT 118 BUCKSKIN CT., ALVARADO, TEXAS 76009, HAS BEEN IDENTIFIED AS A PUBLIC NUISANCE AND FRANKLIN CREDIT HAS BEEN IDENTIFIED AS THE PERSON RESPONSIBLE FOR CAUSING OR MAINTAINING A PUBLIC NUISANCE ON THE PREMISES."

Detective Steve Shaw spoke in reference to Chapter 343 of the Texas Health & Safety Code, the premises located at 118 Buckskin Ct., Alvarado, Texas 76009, has been identified as a public nuisance and Franklin Credit has been identified as the person responsible for causing or maintaining a public nuisance on the premises. This case began on August 25, 2010 due to overgrown grass, weeds, and debris on the property. When Detective Shaw investigated the property, he discovered the double wide mobile home on the property had been vandalized. Three juveniles were identified as committing the crime but Detective Shaw was unable to get the mortgage company to sign any paperwork so the case was left suspended at that time. The

second visit to this property was due to arson where half the kitchen and dining area had been burned and no one was found responsible for this act. The third time Detective Shaw was called to the property was for public nuisance but when he went out, he found the mobile home had been boarded up and the property had been mowed so the case was cleared by abatement. For the current case, Detective Shaw determined the owner to be Russell Johnson of Cleburne, but he informed Detective Shaw he lost the property due to foreclosure to Franklin Credit. Franklin Credit was sent certified letters which they received and the case was filed in Justice of the Peace, Precinct #3. No one from Franklin Credit appeared in court, so Judge Jacobs dismissed the case so it could be filed with Commissioner's Court. Notice of Nuisance letters were sent by certified mail and received by Franklin Credit. Detective Shaw returned to the property last week and nothing had been done on the property. The hearing was closed at 2:35 P.M.
