1. GROUNDBREAKING CEREMONY FOR THE JOHNSON COUNTY ADULT PROBATION BUILDING – 425 W. CHAMBERS STREET, GUINN JUSTICE CENTER COMPLEX, CLEBURNE, TEXAS

Commissioner's Court conducted a [Groundbreaking Ceremony](#) for the Johnson County Adult Probation Building to be located at 425 W. Chambers Street, Guinn Justice Center Complex, Cleburne, Texas. Judge John E. Neill, 18th Judicial District Judge, introduced dignitaries present for the Groundbreaking Ceremony. Judge Roger Harmon expressed his appreciation to Judge William Bosworth, 413th Judicial District Judge, for his assistance in securing the properties necessary to build the new Adult Probation Building. Senator Brian Birdwell told the Adult Probation employees what a valuable job they perform for the County and he appreciates what they do. Commissioners Don Beeson, Troy Thompson, Jerry Stringer
