BE IT KNOWN that on the 10th day of December, 2012, the Honorable Commissioner's Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M., with all members present, and following the Invocation led by Phil Robertson, Keene Church of Seventh Day Adventists, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on December 6, 2012 at 1:15 P.M., were considered:

1. PRESENTATION OF PLAQUES TO RETIRING JOHNSON COUNTY EMPLOYEES

Detective Steve Shaw spoke in reference to Chapter 343 of the Texas Health & Safety Code, the premises located at 9117 N. Monterrey Drive, Alvarado, TX 76009, has been identified as a public nuisance and Wells Fargo Bank, NA has been identified as the person responsible for causing or maintaining a public nuisance on the premises. This case began on August 30, 2012 with complaints of overgrown grass and weeds which would attract and harbor mice, mosquitoes and vermin. This property had previously been presented to Commissioner's Court in October 2011. Photos were taken and Notice of Violation letters were sent to Wells Fargo Bank, NA, which Wells Fargo did receive. The property was not abated at this time. Since this property had been previously presented, Det. Shaw did not send this to Justice of the Peace #3. Det. Shaw did send out Notice of Nuisance letters stating the property would be presented to Commissioner's Court on today's date. This allowed Wells Fargo more time to abate the property, but again nothing was done. The property was revisited on November 30, 2012 to verify that the property still had not been abated. At that time the case was put together to present today to Commissioner's Court for action. The hearing was closed at 9:47 A.M.
