#### INTERLOCAL AGREEMENT

#### BETWEEN THE CITY OF CLEBURNE AND COUNTY OF JOHNSON

#### 2013-14 BYRNE JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AWARD

This agreement is made on the date of the last party's signature to this agreement and is between the County of Johnson, Texas, hereinafter referred to as "County" and the City of Cleburne, acting by and through its governing body, the City Council, hereinafter referred to as "City". The County and City make the following findings in entering into this agreement.

WHEREAS, this agreement is made pursuant to the authority of Section 791.001 – 791.029 of the Texas Government Code; and

WHEREAS, the subject of this contract is necessary for the benefit of the public and each party has the legal authority to perform and to provide the government function or service which is the subject matter of this agreement; and

WHEREAS, the parties find that the performance of this agreement is in the common interest of both parties; and

WHEREAS, each governing body, in performing governmental functions or in paying for the performance of governmental functions hereunder, shall make that performance or those payments from current revenues legally available to that party; and

WHEREAS, the CITY and the COUNTY have been informed that they are eligible for a Justice Assistance Grant (JAG) from the United States Department of Justice, Bureau of Justice Assistance in the amount of \$13,422; and

WHEREAS, the above grant requires a mutual allocation of funds, the CITY and COUNTY have reached an agreement on the division of above funds; and

WHEREAS, each governing body finds that the performance of this Agreement is in the best interest of the both parties, that the undertaking will benefit the public, and that the division of costs fairly compensates the performing party for the services or functions under this agreement; and

WHEREAS, the CITY agrees to provide the COUNTY \$6,711 from the JAG award of \$13,422 for the purchase of a Video Evidence Capture Kit and Body worn cameras; and

NOW, THEREFORE, the CITY and COUNTY agree as follows:

#### Section 1:

CITY AND COUNTY agree that the CITY will act as the fiscal agent for JAG funds totaling \$13,422.

#### Section 2:

CITY agrees to pay COUNTY a total of \$6,711 (50%) out of the JAG funds actually received by the CITY within 30 days after CITY receives such funds.

#### Section 3:

CITY agrees to use \$6711 for the Crime Analysis and Reporting Program.

#### Section 4:

COUNTY agrees to use \$6711 for the purchase of a Video Evidence Capture Kit and Body Worn cameras.

#### Section 5:

By entering into this Agreement the parties do not intend to create any rights or obligations other than those specifically set forth herein and the Agreement shall not create rights in persons not a party to this Agreement.

#### Section 6:

The signatures to this Agreement warrant that each has the authority to enter into this agreement on behalf of the entity they represent.

## Section 7:

This Agreement is made and entered into this 28 day of October , 2013.
