I. UNFINISHED BUSINESS

1. CONSIDERATION OF INTERLOCAL COOPERATION AGREEMENT
BETWEEN THE COUNTY OF JOHNSON AND THE CITY OF GRANDVIEW
REGARDING PLAT APPROVAL JURISDICTION IN THE CITY'S ETJCOUNTY JUDGE'S OFFICE

County Judge Roger Harmon, seconded by Comm. Beeson, made a motion to approve the Interlocal Cooperation Agreement between the County of Johnson and the City of Grandview Regarding Plat Approval Jurisdiction in the City's ETJ-County Judge's Office and to give the County Judge the authorization to sign.

Comm. Stringer, seconded by Comm. Howell, made a motion to approve the Interlocal Cooperation Agreement between the County of Johnson and the City of Grandview Regarding Plat Approval Jurisdiction in the City's ETJ-County Judge's Office, and to give the County Judge the authorization to sign with the following changes: on the first page of the document, under the heading "Recitals", delete the entire sixth paragraph; and on the second page of the document, under the heading "Agreements", number 1, delete this portion of the paragraph: "Notwithstanding the above, City may enforce Chapter 21, Article 21-II, "Subdivision and Development Ordinance", of the Code of Ordinances of the City of Grandview regarding sanitary sewer service to a subdivision in the ETJ, if applicable. In the event City enforces said Chapter 21, Article II, regarding sanitary sewer service to City sewer mains, County will not have the authority or be responsible for issuing permits for on-site sewage facilities. In the event City determines that sanitary sewer service to City sewer mains is not required, County will have the authority and be responsible for issuing permits for on-site sewage facilities".

2. <u>CONSIDERATION OF POTENTIAL PEER ORGANIZATIONS FOR</u> COMPENSATION SURVEY-PERSONNEL DEPARTMENT

Comm. Howell, seconded by Comm. Bailey, made a motion to approve the <u>Potential Peer Organizations</u> for Compensation Survey-Personnel Department by removing Midland County and Ector County from the list which will leave: Comal County, Guadalupe County, Hays County, Randall County, Taylor County, Wichita County, Ellis County, Parker County, Tarrant County, and the City of Cleburne as Johnson County's list of 10 Peer Organizations.
