Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse
thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and
all business that may lawfully be brought before the same. The meeting was called to order at
9:01 A.M., with all members present, and following the Invocation led by Pastor Eddie Scheler,
Ascension Lutheran Church, Cleburne, and the Pledge of Allegiance, the following items, having
been lawfully posted and filed for record in the Office of the County Clerk on January 7, 2016 at
1:54 P.M., were considered:

Commissioner Jerry Stringer, Precinct #3, announced that Johnson County had 4 kids in the 4H Program that went to a National Meet in Denver, Colorado and won. He said all 4 kids ranked in the top 10 and that speaks to the quality of the kids we have in Johnson County as well as the quality of the programs we have in Johnson County.
