ORDER AUTHORIZING TEXAS INDEPENDENCE DAY FIREWORKS SALES

The Johnson County Commissioners Court met on February 8, 2016 in regular session for the consideration of authorizing Texas Independence Day fireworks sales in Johnson County.

WHEREAS, the Commissioners Court of Johnson County is authorized under Occupations Code Section 2154.202(h)(1), to issue an order allowing retail fireworks permit holders to sell fireworks to the public in celebration of Texas Independence Day; and

WHEREAS, on the 8th day of February, 2016 the Commissioners Court of Johnson County has determined that conditions are favorable to issue such an Order;

A motion was made by Commissioner Rick Bailey and seconded by Commissioner Jerry Stringer that: The Commissioners Court of Johnson County adopts this order authorizing the sale of fireworks to the public by retail fireworks permit holders during the Texas Independence Day period beginning February 25, 2016 and ending at midnight March 2, 2016, subject to the following restrictions:


- a. This order expires on the date the Texas Fire Service determines drought conditions exist in the county or midnight, March 2, 2016, whichever is earlier.


Said motion was approved by a vote of the Commissioners Court on the 8th day of February, 2016.

The Commissioners Court of Johnson County, Texas does hereby enter this order authorizing Texas Independence Day fireworks sales.


