COMMISSIONERS COURT

BE IT KNOWN that on the 20th day of June, 2017, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M., with all members present, and the following items, having been lawfully posted and filed for record in the Office of the County Clerk on June 16, 2017 at 4:25 P.M., were considered.

I. WORKSHOP

The Commissioners Court convened into Workshop Session at 9:01 A.M. to discuss Dispatch and Jail Fees for Municipalities.

The Commissioners Court recessed at 10:30 A.M. and reconvened back into Workshop Session at 10:52 A.M. to discuss County Radio Expenses and Annual Subscriber Unit Fee.

The Commissioners Court reconvened into Open Session at 12:21 P.M. to consider the following:

I. NEW BUSINESS

1. CONSIDERATION OF DISPATCH AND JAIL FEES FOR MUNICIPALITIES

Judge Harmon, seconded by Comm. Bailey, made a motion to have the Court negotiate with all Johnson County cities to hold their Class C Misdemeanors at a rate of \$48.14 per day, effective September 1, 2017.

All voted aye; motion carried.

Judge Harmon, seconded by Comm. Bailey, made an amended motion to have the effective date start October 1, 2017.

All voted aye; motion carried.

Comm. Woolley, seconded by Comm. Stringer, made a motion to enter into agreement with the City of Keene to dispatch for their city in the amount of \$139,143.00, subject to Keene City Council approval. For the remaining municipalities, there will be no charges at this time until the rest of the options have been further researched. Due to the existing contract, the City of Cleburne is an exception to this motion.

All voted aye; motion carried.

Comm. Woolley, seconded by Comm. Stringer, made an amended motion to have an effective date of October 1, 2017.

All voted aye; motion carried

2. CONSIDERATION OF COUNTY RADIO EXPENSES AND ANNUAL SUBSCRIBER UNIT FEE

Judge Harmon, seconded by Comm. Woolley, made a motion to increase radio fees by \$1.00 per radio, per month, effective October 1, 2017.

All voted aye; motion carried.

There being no further business before the Court concerning this agenda, Commissioners Court adjourned at 12:50 P.M
