She said this hearing was for setting the Reinvestment Zone only, any future tax abatements, if any, would be discussed at a later time. She said there has been a lot of misinformation about what type of business it would be. Due to confidentiality clauses, the name of the business is closed. She said the business isn't a prison, a game ranch, a tannery, nor a slaughterhouse, but it is light manufacturing. There was a whole host of concerned citizens present to speak against this business. Among them were: Jennie Manasco, Jim Manasco, John McNaughton, Bennie Jeter, Russell Hackler, Bruce Medley, Carolyn McNaughton, April Dunn, Corina Watson, Amy Bledsoe, Meg Barrow, Teresa Monk, Brett Bledsoe and Amber Linder. Among their concerns were the size of the proposed building, not wanting a manufacturing business in the middle of residential properties, the increased noise and traffic, lower property values, and the impact on the air quality. There being no one else to speak, the hearing was closed at 12:37 P.M.
