COMMISSIONERS COURT

BE IT KNOWN that on the 13th day of October, 2017, the Honorable Commissioners Court of Johnson County, Texas, met in Regular Session at the Johnson County Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:04 A.M. (the County Judge stated the time as 9:00 A.M.), with all members present, and following the Invocation led by County Judge Roger Harmon, and the Pledge of Allegiance, the following items, having been lawfully posted and filed for record in the Office of the County Clerk on October 6, 2017 at 4:15 P.M., were considered:

IV. WELCOME VISITORS, ANNOUNCEMENTS & PRESENTATIONS

1. PRESENTATION OF THE 2017 ANNUAL ACHIEVEMENT OF EXCELLENCE IN PROCUREMENT AWARD TO THE JOHNSON COUNTY PURCHASING DEPARTMENT FROM THE NATIONAL PURCHASING INSTITUTE

A presentation of the [2017 Annual Achievement of Excellence in Procurement Award](#) to the Johnson County Purchasing Department from the National Purchasing Institute was given by County Judge, Roger Harmon, Commissioner Rick Bailey, Pct. #1, Commissioner Kenny Howell, Pct. #2, Commissioner Jerry Stringer, Pct. #3, and Commissioner Larry Woolley, Pct. #4 to Ralph McBroom, Johnson County Purchasing Agent and his team.

County Judge, Roger Harmon as well as Commissioner Rick Bailey, Pct. #1, Commissioner Kenny Howell, Pct. #2, Commissioner Jerry Stringer, Pct. #3, and Commissioner Larry Woolley, Pct. #4 took a moment to recognize Abby Sellers of the American Cancer Society in honor of Breast Cancer Awareness Month. Sellers announced the greater Burleson area Relay for Life is April 27, 2018 at Jellystone Park, and the Johnson County Relay for Life will be at The Depot on April 28, 2018.

2. PRESENTATION OF LENGTH OF SERVICE AWARDS TO JOHNSON COUNTY EMPLOYEES

Employees of Johnson County were recognized for their service to Johnson County and employees were given Service Pins, [as attached to these Minutes](#).

V. PUBLIC PARTICIPATION

[Corinna Watson, representing Stop Project Mustang](#) spoke against New Business Item #4, Consideration and Execution of Abatement Order with Louis Vuitton U.S. Manufacturing, Inc.-County Judge's Office. She addressed the Johnson County Policy for Tax Abatement and the three things that were evaluated, Employment Impact, Fiscal Impact, and Community Impact.

[April Dunn, representing Stop Project Mustang](#) spoke against New Business Item #4, Consideration and Execution of Abatement Order with Louis Vuitton U.S. Manufacturing, Inc.-County Judge's Office. She addressed her feelings that there had been no community involvement, and how she believed the Elected Officials chose business over the citizens.

[Eric Baze, representing Stop Project Mustang](#) spoke against New Business Item #4, Consideration and Execution of Abatement Order with Louis Vuitton U.S. Manufacturing, Inc.-County Judge's Office. He addressed several risk points with the primary being that he felt

Johnson County will be, at some point, left with sole fiscal and regulatory responsibility of the project, and the City of Keene will no longer be involved.

[Bobby de la Garza, who serves on the Cleburne Economic Development Board](#) and the Johnson County Economic Development Board, spoke in favor of Louis Vuitton coming to the community. He stated that it is a good thing to attract this manufacturing firm to the County and that the community will strongly benefit.

[Michael Talley, representing the City of Keene, Economic Development](#) spoke in favor of New Business Item #4, Consideration and Execution of Abatement Order with Louis Vuitton U.S. Manufacturing, Inc.-County Judge's Office. He discussed how this was a good opportunity for the County, and some of the potential benefits that would stem from the project. Talley noted that the City of Keene had applied for a Capital Fund Grant to expand infrastructure. He finished with a quoted statement of City of Keene Mayor, James Chapline, and reiterated that this was a good opportunity.

[Dan Boutwell, representing the Johnson County Economic Development Commission](#) (JCEDC) spoke in favor of New Business Item #4, Consideration and Execution of Abatement Order with Louis Vuitton U.S. Manufacturing, Inc.-County Judge's Office. He stated that not only has he been a resident of Johnson County for the past 40 years, but he is also a Professional Planner. He complimented the ability to bring in a well-established, international firm, and said the process was done with a high level of professionalism. He ended with the comment that the primary benefits to the County are tremendous, and the secondary benefits will last past the Tax Abatement.
