### EARLY VOTING POLLING LOCATIONS MAY 22, 2018 PRIMARY RUN-OFF ELECTION (CENTROS PARA VOTACIÓN ADELANTADA 22 DE MAYO DEL 2018 ELECCIÓN DECISIVA PRIMARIA)

May 14, 2018 through May 18, 2018 is the period for early voting by personal appearance (Sec. 85.001). Any voter qualified to vote in the May 22, 2018, Primary Run-Off Election is eligible for early voting by personal appearance.

Early voting by personal appearance will be conducted at all following locations:

Monday, May 14, 2018 – Friday, May 18, 2018 hours: 7:00 am until 7:00 pm.

#### **Sec. 85.062 Texas Election Code**

(2) The Commissioners court of a county with a population of 120,000 or more but less than 400,000 shall establish one or more early voting polling places other than the main early voting polling place in each Commissioners precinct containing territory covered by the election.
