DESIGNATE A PORTION OF STATE HIGHWAY 171 SOUTH AS
GEORGE W. MARTI MEMORIAL HIGHWAY

WHEREAS, Remarkable men and women came out of the greatest generation -- thus was George W. Marti. Growing up north of Burleson, at age 17, George Marti received his Radio Telephone First Class Engineering license and 6 months later was a full-time transmitter engineer at KFJZ Radio, where he worked until he joined the United States Marine Corps at the start of World War II; and

WHEREAS, After graduating from the first radar class at the Naval Research Lab in Washington, D.C. and then serving in the South Pacific, George Marti returned to Texas, airing the first broadcast of his radio station, KCLE, on Easter Sunday 1947; and

WHEREAS, Whether active in the business of radio, electronics, banking, Charolais cattle, or six-term mayor of the City of Cleburne, George Marti believed in giving back and helping others, especially in the area of education; and

WHEREAS, The Marti Foundation has been providing educational scholarships for the past 28 years to Johnson County students who could not otherwise have afforded a college education; and

WHEREAS, Members of the Johnson County community are honored to pay tribute to George W. Marti, entrepreneur and philanthropist, one whose life of service still continues to influence many.

NOW THEREFORE, BE IT RESOLVED THAT, I, Roger Harmon, County Judge of Johnson County, and we the Commissioners of the four Precincts in Johnson County, Texas, do hereby petition the State of Texas to designate that portion of S.H. 171 beginning at the south city limit of the City of Cleburne and ending at the south county line of Johnson County, as the "George W Marti Memorial Highway", and that the Texas Department of Transportation approve at suitable locations consistent with state and federal regulations, appropriate plaques or signs giving notice of the name of the "George W Marti Memorial Highway."





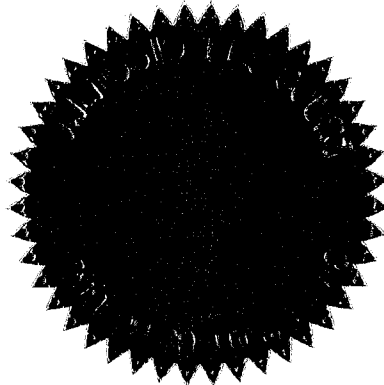
