**COMMISSIONERS COURT ORDER GRANTING AN EXEMPTION UNDER SECTION 262.024, LOCAL GOVERNMENT CODE, FROM THE BIDDING REQUIREMENTS OF SECTION 262.023, LOCAL GOVERNMENT CODE, UPON THE COMMISSIONERS COURT FINDING THAT THE MEDICAL SERVICES PROVIDED BY ONCOLOGY HEMATOLOGY CONSULTANTS, PA DBA THE CENTER FOR CANCER AND BLOOD DISORDER ARE PROFESSIONAL SERVICES**

The Johnson County Commissioners Court met on February 26, 2018 in regular session for the consideration of a contract between Johnson County, Texas and Oncology Hematology Consultants, PA dba The Center for Cancer and Blood Disorder, the Commissioners Court finds that this contract is for professional services and that the Commissioners Court may grant an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code.

A motion was made by Commissioner Bailey and seconded by Commissioner Howell that: "The Commissioners Court find the contract for medical services provided by Oncology Hematology Consultants, PA dba The Center for Cancer and Blood Disorder is a contract for professional services and that the Commissioners Court grants an exemption under Section 262.024, Local Government Code, from the competitive bidding requirements of Section 262.023, Local Government Code, and enter an order to that affect, and that the Commissioners Court approve the contract for medical services with Oncology Hematology Consultants, PA dba The Center for Cancer and Blood Disorder.

Said motion was approved by a vote of the Commissioners Court on the 26<sup>th</sup> day of February, 2018.


**NOW THEREFORE BE IT RESOLVED AND ORDERED:**






