ORDER AUTHORIZING SAN JACINTO DAY FIREWORKS SALES

The Johnson County Commissioners Court met on March 12, 2018 in regular session for the consideration of authorizing San Jacinto Day fireworks sales in Johnson County.

WHEREAS, the Commissioners Court of Johnson County is authorized under Occupations Code Section 2154.202(h)(1), to issue an order allowing retail fireworks permit holders to sell fireworks to the public in celebration of San Jacinto Day; and

WHEREAS, on the 12th day of March, 2018 the Commissioners Court of Johnson County has determined that conditions are favorable to issue such an Order;

A motion was made by Commissioner Bailey and seconded by ~~Commissioner~~ County Judge Roger Harmon that: The Commissioners Court of Johnson County adopts this order authorizing the sale of fireworks to the public by retail fireworks permit holders during the San Jacinto Day period beginning April 16, 2018 and ending at midnight April 21, 2018, subject to the following restrictions:

- a. This order expires on the date the Texas Fire Service determines drought conditions exist in the county or midnight, April 21, 2018, whichever is earlier.




