On June 5, 2018 Paul and Peggie Jones from the organization Stop Forced Annexation in Johnson County submitted to the Johnson County Elections Office, on behalf of the registered voters of Johnson County, a petition containing 11,913 signatures. This petition pertains to Johnson County as being classified as a Tier 2 county as described in SB6 of the 85th Texas Legislature Special Session, as codified in Chapter 43 of the Texas Local Government Code, in regards to Municipal Annexation. The petition needs to contain 8,904 signatures of registered voters in Johnson County for the Commissioners Court approval. The Johnson County Elections Office verified 9,855 qualified signatures.
