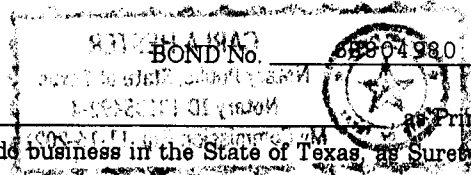

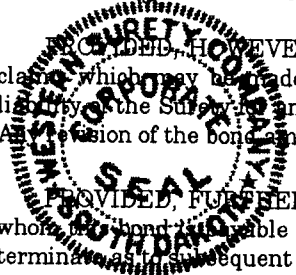
THE CONDITION OF THE ABOVE OBLIGATION IS SUCH, That whereas, the above bounden Principal was on

terminate as to subsequent acts of the Principal.



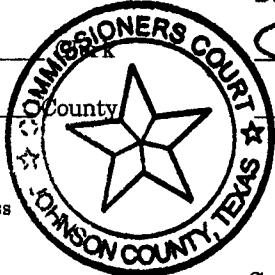

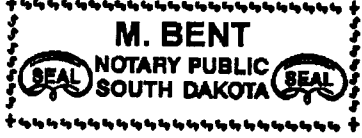
