BE IT KNOWN that on the 27th day of March 2019, the Honorable Commissioners Court of Johnson County, Texas, met in Special Session at the Courthouse thereof, in the City of Cleburne, Johnson County, Texas, for the purpose of transacting any and all business that may lawfully be brought before the same. The meeting was called to order at 9:00 A.M. with all members present, and the following items, having been lawfully posted and filed for record in the office of the County Clerk on March 21, 2019 at 1:17 P.M. were considered:

I. PUBLIC HEARINGS

The Commissioners Court opened a Public Hearing at 9:00 A.M. to discuss:

1. APPROVING AND ADOPTING THE REVISED JOHNSON COUNTY FLOOD DAMAGE PREVENTION ORDER OF 2019 AND DIGITAL FLOOD INSURANCE RATE MAPS REVISION EFFECTIVE APRIL 5, 2019 (FIRM) AND THE FOURTH REVISED COUNTYWIDE FLOOD INSURANCE STUDY (FIS) FOR JOHNSON COUNTY, TEXAS AND INCORPORATED AREAS EFFECTIVE APRIL 5, 2019, NUMBER 48251CV001B AND 48251CV002B

There being no one from the public wishing to speak, County Judge, Roger Harmon turned the discussion over to County Attorney, Bill Moore. The County Attorney stated the reason for the revised order was due to the update of information. He stated that since the previous Johnson County Flood Damage Prevention Order was signed by the Court in 2012, the FEMA maps have been updated and revised and that there has been a Fourth Revised Countywide Flood Insurance Study for Johnson County, Texas and Incorporated Areas.
