Agreement for Information Technology Products and Services

Amendment No. 1

Conduent Government Records Services, LLC

Johnson County, Texas

This first amendment ("Amendment No. 1"), to the Agreement for Information Technology Products and Services dated September 23, 2013 ("Agreement") is made by and between **Conduent Government Records Services, LLC**, an Avenu Holdings, LLC company (formerly Government Records Services, Inc.) ("Conduent"), 8600 Harry Hines Blvd., Dallas, TX 75235 and **Johnson County**, 2 North Main Street, Cleburne, TX 76033 ("Client"). Conduent and Client (each individually a "party" and collectively, the "parties") agree as follows:

1. This Amendment No. 1 is effective on March 20, 2019 ("Amendment Effective Date").
2. Section 1 (Term) of the Agreement is modified as follows:

This Agreement is hereby extended through June 22, 2020, unless otherwise extended or terminated by the parties in accordance with the provisions of this Agreement ("Term").

3. The Agreement is amended to add the following Section 27:

27. Conduent Government Records Services, LLC verifies that it does not boycott Israel and will not boycott Israel during the term of this contract. The term "boycott Israel" is defined by Texas Government Code Section 808.001, effective September 1, 2017. **Conduent Government Records Services, LLC** further verifies that it is not engaged in business with Iran, Sudan, or any foreign terrorist organization. The term "foreign terrorist organization" means an organization designated as foreign terrorist organization by the United States Secretary of State as authorized by 8 U.S.C. Section 1189.

4. As of the Amendment Effective Date, Schedule A (Statement of Work), Section A (Scope of Services), is amended by deleting the following statement under ACS Responsibilities:

"ACS will provide digital image to microfilm conversion and storage for archiving."

5. As of the Amendment Effective Date, Schedule A (Statement of Work), Section C (Payment and Rates), is amended by removing the following from the list of services and pricing:

Security Microfilm..... \$0.05/image

6. All other terms and conditions of the Agreement, except as modified by this Amendment No. 1, shall remain in full force and effect.
