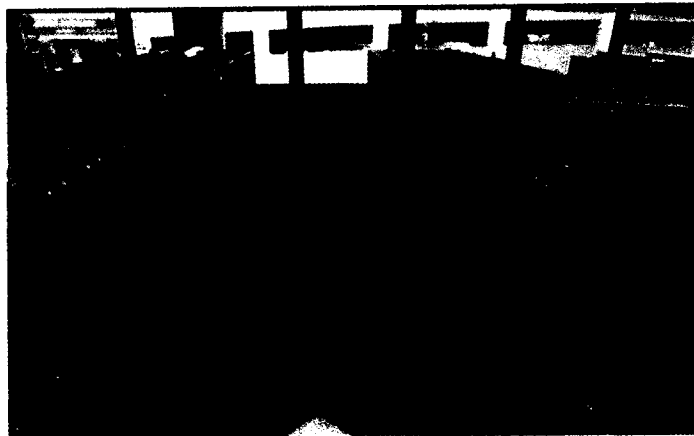

HIGH DENSITY SOLUTION

Kofile considered many factors when designing its shelving solution. This includes the effects that the shelving materials will have on the archival materials they will hold, as well as the surrounding environment. This shelving has a custom finish with an archival-quality, environmentally-friendly paint that will not off-gas and damage documents.



Johnson County can rest assured that this shelving will not buckle or deteriorate. These units are also beneficial because they allow for easy expansion should the Recorder wish to re-arrange the units or add more units in the future.

SHELVING SCHEMATICS

The Johnson County's custom schematics include steel back panels, 20"D case style uprights, kick plates, un-slotted shelving, shelf reinforcements, and shelf supports. All 4Post™ Shelving comes with a lifetime warranty. This system is approved for archives. Each unit of shelving has a capacity of approximately 50-65 binders.

Each unit features interlocking keyhold uprights in addition to double rivet shelf supports to maximize the durability and versatility of the units. The units can hold volumes up to 20"D, and they are assembled without the use of bolts, nuts, or clips. This system allows for single-entry units for placement against a wall and double-entry units for placement of units back-to-back. Units are also designed "mobile ready" to allow for storage expansion and conversion to a TrakSlider System if needed.
