**AMENDMENT AND MODIFICATION TO REQUIREMENTS CONTRACT –
JURY ADMINISTRATION SYSTEM between Johnson County, Texas and Judicial
Systems, Inc.**


The Requirements Contract – Jury Administration System Agreement entered into June 23, 2014 is modified and amended pursuant to Section 9 B and Section 14 to provide that Johnson County is purchasing the Genesis Chat module at a price of \$8,000.00. Said module shall be delivered and operational by March 17, 2023. Annual support for the Genesis Chat module shall be \$2,500.00 per year. Payment timing may be adjusted or payment amounts prorated to coordinate with existing annual payments for Technical support.

All other terms of the Agreement entered on June 23, 2014 between Johnson County and Judicial Systems, Inc. shall remain in effect and unchanged.
