Project Scope

OVERVIEW

1. Project Plan High Level Scope

- Consult and Assist Johnson County Sheriff Office
- Consulting Technology services related to design of support in the new 911/ Dispatch Center
 - Design, acquisition, and management of Telecommunications services to support the center
 - 911 Dispatch consoles and dependencies of multiple manufacturers.
- Identify conflicts and resolve with Design team and Construction manager.
- Develop scope of new consoles and Integration of systems in the new building
- Validate cooperative agreement for purchasing department to procure consoles
- Coordinate dependencies with all considered vendors of consoles
- Use TodoVerde technology team to coordinate all parties related to 911/ Dispatch Center
- TodoVerde Solution Architect and Engineering team to work with Johnson County IT department to insure successful technology design in 911/ Dispatch Center and go live plan
- Review and determine go live plan with fall back plan for transition to new consoles
- Confirm transition plan will not impact dispatch capability and if so to the minimum possible.

2. Assumptions

- All work performed will be documented and delivered to Johnson County.
- Johnson County applicable parties will be available on scheduled review meetings and calls.
- Any hours of the Block of Time (BoT) that are not used, do not expire and can be used by Johnson County for any other professional service they deem necessary.
- If documented work exceeds the initial BoT, TodoVerde must have authorization from Johnson County prior to work performed over and above allotted BoT.
- If at any time TodoVerde is notified to cease engagement all remaining hours can either be transferred to another project or consulting engagement but will require a new Scope of Work to be approved and executed.
- Cease notification must be made in writing by approved representative listed in section 4 of this scope.

3. Pricing and Payment

- Block of Time (BoT) is invoiced upon execution of Scope of Work
- Payment terms are net 30
- Pricing is based on the BoT quote with description of resources
