
ORDER APPOINTING PURCHASING AGENT


On the 9th day of January, 2026, the undersigned District Judges of the 18th, 249th, and 413th Judicial Districts, the Johnson County Judge, and the Commissioner of Precinct Number 4, in compliance with Local Government Code Section 262.011, hereby appoint Lance Anderson as Purchasing Agent of Johnson County, Texas for a two-year term of office.


It is further Ordered that during his appointment as Purchasing Agent his annual salary shall be in the amount of \$125,262.00 per year, payable in equal bi-weekly installments. It is further Ordered that he shall be paid additional compensation of \$6,000.00 annually for travel allowance to be paid in equal bi-weekly installments. It is further Ordered that he shall be paid a cell phone allowance of \$40.00 per month.




