## ORDER TERMINATING THE JOHNSON COUNTY ECONOMIC DEVELOPMENT COMMISSION (PREVIOUSLY KNOWN AS THE JOHNSON COUNTY INDUSTRIAL COMMISSION)

**WHEREAS**, Johnson County Commissioners Court previously established the Johnson County Industrial Commission to promote economic development in Johnson County; and

**WHEREAS**, in 1992, the Johnson County Industrial Commission began operating as the Johnson County Economic Development Commission (JCEDC); and

**WHEREAS**, the JCEDC was funded primarily through contributions from Johnson County and supplemental contributions from various municipalities throughout the County; and

**WHEREAS**, over time, most of the contributing municipalities established their own economic development departments or directors, resulting in Johnson County becoming the sole financial contributor to the JCEDC; and

**WHEREAS**, in previous budgets and through the 2023-2024 budget year, Johnson County had budgeted the amount of \$140,000.00 to be paid to the JCEDC; and

**WHEREAS**, Johnson County discontinued budgeting the amount of \$140,000.00 to be paid to the JCEDC in the 2024-2025 budget year; and

**WHEREAS**, Johnson County in the 2024-2025 budget year budgeted the amount of \$125,000.00 to pay for an Economic Development Director rather than budget funds to the JCEDC; and

**WHEREAS**, any assets of the JCEDC have been transferred to Johnson County, and all funds belonging to the JCEDC have been delivered to the Johnson County Treasurer to be deposited into the General Fund of Johnson County.

**NOW THEREFORE IT IS ORDERED BY THE COMMISSIONERS COURT OF JOHNSON COUNTY, TEXAS THAT:**


1. The Johnson County Economic Development Commission (JCEDC) is hereby terminated and dissolved;
2. All assets, records and property of the JCEDC shall become the property of Johnson County; and
3. All funds previously held by the JCEDC shall become funds of Johnson County and deposited in the General Revenue Fund.






