Johnson County Constable Pct 1. has adopted a detailed written policy on racial profiling. Our policy:

- 1)clearly defines acts constituting racial profiling;
- 2)strictly prohibits peace officers employed by the Johnson County Constable Pct. 1 from engaging in racial profiling;
- 3)implements a process by which an individual may file a complaint with the Johnson County Constable Pct. 1 if the individual believes that a peace officer employed by the Johnson County Constable Pct. 1 the individual;  
has engaged in racial profiling with respect to
- 4)provides public education relating to the agency's complaint process;
- 5)requires appropriate corrective action to be taken against a peace officer employed by the Johnson County Constable Pct. 1 who, after an investigation, is shown to have engaged in racial profiling in violation of the Johnson County Constable Pct. 1 policy;
- 6)requires collection of information relating to motor vehicle stops in which a warning or citation is issued and to arrests made as a result of those stops, including information relating to:
  - a.the race or ethnicity of the individual detained;
  - b.whether a search was conducted and, if so, whether the individual detained consented to the search;

- c. whether the peace officer knew the race or ethnicity of the individual detained before detaining that individual;
  - d. whether the peace officer used physical force that resulted in bodily injury during the stop;
  - e. the location of the stop;
  - f. the reason for the stop.
- 7) requires the chief administrator of the agency, regardless of whether the administrator is elected, employed, or appointed, to submit an annual report of the information collected under Subdivision 6) to:
- a. the Commission on Law Enforcement; and
  - b. the governing body of each county or municipality served by the agency, if the agency is an agency of a county, municipality, or other political subdivision of the state.
- The Johnson County Constable Pct. 1 has satisfied the statutory data audit requirements as prescribed in Article 2.133(c), Code of Criminal Procedure during the reporting period.
