Subj: Juvenile Services Lobby- Ceiling Raise

Scope:

- Raise the ceiling grid in the Juvenile Services Lobby approx. 12".
Existing Ceiling is approx. 7'10" AFF
New Ceiling height would be approx. 8'10"
- Add 12" of new drywall to the top of the existing wall studs.
- Float & Texture newly added drywall to match existing wall texture as close as possible.
- Paint the entire room walls, floor to ceiling, for appropriate paint match.
- Raise 4 existing sprinkler heads to new ceiling height.

Total: \$5,973. (no tax)

Note:

- HVAC- Diffusers can be raised due to existing flex duct connections.
- New Grid, Ceiling Tile & Lighting are already included in the base bid proposal for this project.

*Excludes: Excludes flooring, wall base, doors & windows, concrete, structural steel, roofing & insulation.
