COMMISSIONERS COURT ORDER AUTHORIZING A TEXAS LAWYERS INSURANCE EXCHANGE POLICY IN LIEU OF A BOND FOR COUNTY COURT AT LAW JUDGE JOHN E. NEILL

WHEREAS, John E. Neill is the duly elected county court at law judge of County Court at Law Number 1 of Johnson County, Texas; and

WHEREAS, Section 25.0006(a-1) of the Government Code requires a judge of a statutory county court to execute a bond of not less than \$1,000 nor more than \$10,000 conditioned on the faithful performance of all duties of office; and

WHEREAS, Section 25.0006(a-1) of the Government Code requires a judge of a statutory county court that presides over guardianship proceedings to execute a bond in the amount of \$500,000 conditioned that the judge will perform the duties of the office and the duties required by the Estates Code; and

WHEREAS, Judge John E. Neill, has secured an insurance policy #02641J04 from Texas Lawyers Insurance Exchange to provide insurance that meets or exceeds the requirements of Section 25.0006 (a-1) of the Government Code; and

WHEREAS, Section 88.008 of the Local Government Code requires the commissioners court by order to authorize insurance coverage against losses that would have been covered by a bond.

NOW THEREFORE BE IT RESOLVED AND ORDERED:

The Commissioners Court of Johnson County, Texas does hereby authorize the Texas Lawyers Insurance Exchange Policy #02641J04 in lieu of a bond for County Court at Law Judge John E. Neill.

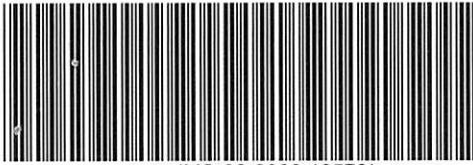
