ORDER DECLARING PROPERTY SURPLUS AND AUTHORIZING DONATION TO A CHARITABLE ORGANIZATION PURSUANT TO TEXAS LOCAL GOVERNMENT CODE § 263.152 (a) (4)


The Johnson County Commissioners Court **FINDS** that certain personal property belonging to the County is surplus property with only nominal monetary value. The Court **FURTHER FINDS** that the property is subject to donation to a non-profit organization pursuant to Texas Local Government Code § 263.152. The property subject to this Order is more fully described as follows:

NOW THEREFORE BE IT ORDERED:

The Commissioners Court of Johnson County, Texas does hereby enter this Order finding that undertaking to sell the aforementioned property by auction would likely result in no bids or a bid price that is less than the County's expenses required for the bid process, the donation of the property to a non-profit organization within the County serves a public purpose, and the recipient of the property is providing adequate consideration for the property by relieving the County of the costs associated with storing, transporting, and/or disposing of the property; and further **ORDERING** that the property is surplus and the County is authorized to donate the property to Terry's Texas Rangers SCV Camp #1937, or any non-profit organization within Johnson County






